

#### **Grant Money Available to Chapters**

- O \$5000 matching grant to one or more chapters
- O Must be matched "in kind" by land manager
- O \$750 regional grants to chapters; must show result at end of year.
- O Examples: Hocking's group campground gravel, widening of entrance, etc.
- O Examples: Fixing persistently muddy areas at Alum Creek





Deer Creek 2017, worked in teams to tackle 6 common chapter problems:

Example of results from the teamwork/brainstorming session: Raise money:

-(100% profit, \$1,000+)
silent auctions, raffles, ad space with businesses;
-(\$500 profit)
tack auction, pig roast/food event, dice/poker ride, recycling

#### **How OHC funds activities**

#### **Budget year January through December**

- -Must maintain a balanced annual operating budget
- -Each year expenses cannot exceed revenues from membership dues and special programs

#### **Finance committee**

- -Chair appointed by president
- -Treasurer and one person from each region
- -Solicit budget input from all officers and committee chairs
- -Develop the budget
- -Present budget to Executive Cabinet for approval
- -Conduct a review of the Treasurer's books and accounts (oversaw by the directors)

Budget presented to general membership at November meeting for approval
