  - 2. Provide resources to promote the building and maintenance of bridle trails throughout the State of Ohio;
  - 3. Provide financial resources and volunteer services to fellow organizations that support and protect equine-related activities; and
  - 4. Provide support to state and national horse-related issues.

#### 3.0 ARTICLE III: MISSION

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

The property of this corporation is irrevocably dedicated to the mission of the Ohio Horseman's Council as detailed in section 3 of these Bylaws and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member thereof, or to the benefit of any private individual.
