END OF MEMBERSHIP REPORT

CHAPTER OFFICERS: Communicate with new and renewing members!

- * Communication is key to retaining members. Help them to feel a part of the group. Keep them informed of chapter activities.
- * Call, email or mail to welcome new members. Send membership card, next chapter meeting date & location, chapter calendar of events, newsletter.

How do I find a chapter member's address, phone number or email address?

- Ask your chapter treasurer (or membership chair) to look up a chapter member's profile information on the OHC Member Site.
- Your chapter treasurer can print a Members Address List by exporting the online Members List to a spreadsheet (Click on "Export to CSV").

How do I know when a member joins or renews online?

• Chapter treasurer receives a computer-generated email notice from Ohio Support when a member joins or renews online.

<u>Chapter treasurers</u>: **PLEASE process memberships promptly.**

> When members join or renew online themselves:

- You receive a computer-generated email notice from Ohio Support.
 - Go to Member Site (members.ohconline.com). From the Manage Members'
 Dashboard, select Memberships, then Orders. Look to see if they have paid dues.
 - If the order status is "pending", they opted to pay by check or cash. Membership is not active until you receive payment and edit order to "success". Call or email them to provide your mailing address.
 - If the order status is "review", PayPal/credit card payment was <u>not</u> received by OHC. Follow up with member.
 - If PayPal/credit card order status is "success", the State OHC Treasurer has received payment and will reimburse the chapter for chapter portion of dues and chapter charge, if applicable.
 - From Orders, **click on Username to open membership profile.** See if membership is new or renewed, and Individual, Family, Youth or Associate Group type. See their mailing address, phone number, email address, and family members.

> When member joins or renews with paper form and pays you with cash or check:

- Process new or renewing member online at OHC Member Site (members.ohconline.com).
 - Receive computer-generated email notice from Ohio Support.
 - Edit payment Order to "success" if you have their dues payment.
 - Send Dues Summary with state portion of dues and insurance premium, if applicable, to state OHC Treasurer. Checks payable to Ohio Horseman's Council, Inc.
 - Process membership promptly. Only memberships with "success" orders receive the Corral magazine.

CHAPTERS OFFICERS....Please remember these important deadlines:

BY DECEMBER 31: Membership renewals

- Make every effort to get membership renewals by end of year. The equine liability insurance runs along with OHC membership so it is important to renew members so they can retain the insurance beginning January 1. Members may renew online or use a paper form.
- Each chapter's membership form can be downloaded from the chapter page: on the OHC website, under Find Chapter, select chapter and scroll to 'Download Registration'.

BY JANUARY 15: Report officers' information

- Send the state Trail Mileage & Saddle Hours Chair a list of your chapter members' trail mileage and saddle hours for the previous year. You may use the form provided on the OHC website, under Documents, Chapter Trail Mileage & Saddle Hours. Email to: trailmiles@ohconline.com
- Send the state Trail Work Hours Committee Chair a list of your chapter members' trail maintenance hours worked for the previous year. Email to: trailhours@ohconline.com

TWICE A MONTH: Dues Summary

- Send the state Treasurer a completed Dues Summary, listing your latest new and renewed members and the state portion of dues and the insurance payment, if applicable, for each member. Include one check to Ohio Horseman's Council for the total of these payments. The state treasurer's mailing address is on the Dues Summary. Or email: treasurer@ohconline.com
- For members who join or renew online and pay with PayPal, their payments go directly to the state OHC account, and your chapter will be reimbursed for the chapter portion and chapter charge, if any.
- An OHC membership does not commence or renew until the proper form of application, either online or paper form, and payment of dues, are received by the OHC.

BI-ANNUALLY: Attendance at State General Membership Meetings and Regional Meetings

By-Laws Committee – Eric Estill for Jim Wallace

The OHC Executive Cabinet recommends the following by-law change:

OHC Bylaws amendment proposal

Revise the Regional Rep elections as follows:

Under Article VII: Elections, change 7.11

From:

7.1.1 Regional Representatives shall be elected within their region by vote of the county chapters, casting one (1) vote each based on the outcome of a vote taken at the November meeting of the county chapter, with the results reported to the sitting Regional Representative for each region in writing or by e-mail. The candidate in each region receiving the largest number of votes shall be elected.

To:

7.1.1 Regional Representatives shall be elected within their region by vote of the county chapters, casting one (1) vote each based on the outcome of a vote taken at the October or November meeting of the county chapter, with the results reported to the Nominating Committee in writing or by e-mail by December 1. The candidate in each region receiving the largest number of votes shall be elected.

Under Article VII: Elections, change 7.2.4

From:

7.2.4 Nominations for Regional Representative shall be made to the sitting Regional Representative prior to the November county chapter meetings and the sitting Regional Representative shall notify each county chapter as to the nominees prior to a vote being taken.

To:

7.2.4 Nominations for Regional Representative shall be made to the Nominating Committee by October 1 and the Nominating Committee shall notify each county chapter as to the nominees prior to a vote being taken.

STATE TRAIL MILE/SADDLE HOUR AWARD

If you need State Park/Forest or Trail Patches, see me or use the form on the state website. If you have any questions on the program, please let me know.

There were 50 Chapters, one more responding in 2023 than last year. The overall number of members turning in Trail Miles (965) is up 150 members and the total number of miles 316,285 is up 51,281. This covered 30 states and more than five foreign countries!

Saddle Hours were up (5,102) with 26,991 hours and up (26) with 308 members. If you ride in parades that can be Saddle Hours, as well as competitions, practicing for competitions (schooling) or driving your equines (wagon trains).

Forty-eight youth turned in 9,621 Trail Miles. This is up 8 youth and Trail Miles from last year.

Twenty-one youth turned in 2,436 Saddle Hours. This is the same number of youth, but up in hours.

All of these totals will be posted on the State OHC Website www.ohconline.com be sure to look for the TOP TEN ADULTS AND YOUTH!

OHC will not be inducting any new members to the TRAIL RIDER'S HALL OF FAME 25,000 mile LIFETIME accomplishments this year WITH A PERSONALIZED BUCKLE. How close are you? Two members are under 1,000 to go and seven are already over 20,000.

Trail Maintenance Awards

Argonaut Insurance Company (AEIG) Equine Liability Policy

Policy Number ELP2005735-06

- Named insured is the Ohio Horseman's Council, Inc.
- Liability limits \$1,000,000/\$2,000,000
- \$5,000 medical payments for non-OHC members.
- This policy insures OHC (and its members with respect to activities performed for OHC) for bodily injury or property damage caused to others. An example could be a chapter meeting where a guest trips and falls over the sound system wiring set up by the chapter president.
- Best practices require that each chapter send its calendar in advance to Jackie Romaker (OHC Insurance chair) to provide to the insurer, thereby avoiding any surprises.
- Best practices require chapter sign-in sheets to maintain a record of who was in attendance in case a claim should arise.
- Coverage for equine events includes OHC trail riding activities, cutting, roping, sorting, team penning and working cow horse but only if participants provide their own horses.
- This policy also insures OHC, its members and the event venues for <u>scheduled</u> "public event days," meaning claims by non-OHC members for injury or property damage caused by OHC or its member(s) at a scheduled public event. Also known as "event insurance."
 - \$75 for a one-day event, which includes a set-up day and a take-down day.
 - \circ \$40 for a one-day event to name the venue owner as an additional insured

Equisure Insurance

Policy Number B123062096A24

- Insured = individual member or family member of OHC who is currently enrolled as a policy holder. OHC members can purchase this coverage when they join or renew their OHC membership each year. Associate Group and youth memberships are not eligible.
- Liability limits \$1,000,000/\$1,000,000 including claims expense.
- This policy provides <u>excess</u> coverage for accidental injury to any person or property arising out of the use and/or ownership of a horse or a horse-drawn vehicle, including:
 - o Riding a horse on the public highway or elsewhere
 - o Leading a horse along the public highway or elsewhere
 - o Grazing or stabling a horse or circumstances where the horse is not in your control.
- This policy does not cover liability arising out of a business use.
- This policy does not cover damage to you or to your property.
- This policy obligates the insured to "take all reasonable care to prevent accidents" and "to take such additional precautions as the circumstances may require."

Your own Policy of Liability Insurance, typically Homeowner's

Your own policy number

- May or may not cover liability arising from the non-business use or ownership of a horse.
- If you have applicable coverage it will be primary to the Equisure policy.
- Check with your insurance agent!

24 Challenge – Rules of the competition

The goal of the '24 Challenge' is to generate as many new memberships as possible. If each region got at least 24 new memberships, that's almost 150 new, offsetting the loss of memberships from 2022 to 2023 which was 110, loss of members was 154. As of 2-22-24, we are down 334 memberships which would reflect slow renewals for 2024, loss of memberships or other situations whereas the chapter officers need to investigate and consider if it is impacting their current membership numbers. (Low-hanging fruit if it's just getting members motivated to renew.)

- New membership means never being a member of OHC. Membership is one account type whether individual, family, youth, or associate group. (Note: family will have 2 members within their membership as we count the primary holder and a 2nd individual as a voting member. But to make this challenge equal, we'll call it a 1 new membership, no matter the type.) Further, new memberships are new to OHC and do not include returning members from earlier years or members switching from another chapter.
- A chapter can not count a secondary membership as a new membership. The secondary member, if new to OHC, will be counted by their primary chapter.
- Chapters will provide their regional rep or assistant regional rep with the number of new memberships they generate. The regional rep can determine how often they want a report from their chapters.
- The challenge begins Jan 1, 2024, and ends Dec 31, 2024, with the winning region announced at the March, 2025, state meeting.
- Friendly 'jabs' between regions or chapters are allowed.

Benefits to Associate groups to join OHC:

Associate Group can purchase event insurance via our source


- •\$150.00 for each event day as well as the additional insured coverage

Cannot purchase personal equine liability insurance (Equisure).

- Can participate in OHC rides and events like tack swaps, Equine Affaire, Legislative Caucus Day
- Track and report trail mileage and work hours
- Share the workload on trail maintenance; use OHC land management relationships to benefit the association
- Contribute to louder voice at the state level about Ohio's equine industry
- Promote their events or business on the OHC Facebook group (3,000+ followers currently) and chapter/region Facebook groups, state meetings, rides, etc.
- Per Jackie, members of an Associate Group fall under the same insurance structure as OHC members, except for access to Equisure.

Benefits to OHC chapter:

- Members within the associate group could eventually join OHC as an individual, family etc to purchase the low-cost liability insurance, free Horseman's Corral, etc.
- Potential membership growth for the sponsoring chapter. Associate group = 1 membership but if members of the associate group were to join OHC as individuals or family, growth = multiple memberships
- \$6 retained by the chapter from the dues, \$34 to state budget
- Partnership with other like-minded horse enthusiasts; we all want the same thing access to public land, riding, camaraderie, others to ride with, education
- Members of the Associate group could decide to become a primary member of your chapter and have full benefits of membership Free Corral, personal equine liability insurance, voting rights, etc.
